## SPECIAL TOWN MEETING WARRANT Bernardston Elementary School June 17, 2019

To either of the Constables of the Town of Bernardston in the County of Franklin,

### GREETINGS:

In the name of the Commonwealth of Massachusetts, you are hereby directed to notify and warn the inhabitants of said town, qualified to vote in elections and in town affairs, to meet at the Bernardston Elementary School cafeteria, in said Bernardston, the 17th day of June next at seven o'clock in the evening, in the year 2019, then and there to act upon the following articles:

**Article 1:** To see if the Town will vote to raise and appropriate \$47,282.40 to the Pioneer Valley Regional School District FY20 assessment for the first year of a five year contract for the Superintendent of Schools, or take any vote or votes in relation thereto.

**Article 2:** To see if the Town will vote to raise and appropriate the amount of \$2,947,599.60 for Bernardston's share of the PVRs Operating Budget, or take any vote or votes in relation thereto.

**Article 3:** To see if the town of Bernardston will vote to create a regional school district planning committee in accordance with Massachusetts General Laws Chapter 71, Section 14, or take any vote or votes in relation thereto.

**Article 4:** To see if the Town will vote to raise and appropriate the amount of \$20,500 to have a full interconnection application prepared and submitted for a 2,665 kilowatt (+/-) solar installation at the Town Landfill, or take any vote or votes in relation thereto.

**Article 5:** To see if the Town will vote to adopt the Resolution in Support of Changing the State Flag and Seal of Massachusetts, as noted separately, or take any action thereon. *(This is a petitioned article.)*






